July 4 - Fourth day in July (Independence Day)

September 2 - First Monday in September (Labor Day)

October 14 - Second Monday in October (Columbus Day)

November 11 - Eleventh day of November (Veterans' Day)

November 28 - Fourth Thursday in November (Thanksgiving Day)

December 25 - Twenty-fifth day in December (Christmas Day)
